SCHOOL COUNCILS VS. PARENT ASSOCIATIONS / SOCIETIES

School Council

- Unincorporated
- Advisory Capacity
- Volunteers for events organized by the school and supervised by the Principal
- Meets regularly with the Principal regarding education and finance matters
- Activities are covered by the school board's insurance

- Societies
 - Incorporated legal entity with its own governance structure
 - Fundraising and activities organized by societies should not be labelled as school events
 - Eligible to casinos and gaming related revenue
 - Maintain their own accounts, records and insurance

SCHOOL COUNCILS VS. PARENT ASSOCIATIONS / SOCIETIES

- Problems Encountered
 - Who is doing what? (e.g. Hot Lunch)
 - Who is taking care of the records?
 - Who has control of the funds and activities?
 - Should there be insurance?
 - Charitable donations

SHOULD THE SOCIETY CARRY INSURANCE

- Yes, but it depends
 - How active is the group?
 - Can the activities by modified to be school organized?
 - How much money is involved?
- Recommended to carry at least CGL and D&O Insurance
 - Through the school board insurance provider \$1,023 annually
 - Directors and Officers risk being personally liable by participating in society activities
 - Optional coverages are Crime and Property

USE OF FACILITIES

- Policy JG Most recently reviewed in 2022, significant changes in 2017
 - Genesis of the changes was due to custodians not getting paid by users for the extra work generated
- Schools should be available to members of the community
- Access needs to be managed and costs considered
- Principal is in charge of securing the building
- Priority is given to school programs and maintenance needs

USE OF FACILITIES - FEES

- Category I Exempt from fees
 - Activities of the board, meetings of school council, NFPs etc.
- Category 2 Not exempt
 - 2a Profit not intended, community events etc
 - 2b Commercial activities, private groups
- Custodian Fees
 - Usually waived if people clean up after themselves

FACILITY COSTS

- Custodian costs
- Utilities
- Insurance every external user costs the board additional insurance
- Gym floor
 - Annual refinish \$15,000
 - Sand and refinish (10 year) \$65,000
 - Replacement wood (30 year) \$150,000
 - Replacement synthetic \$60,000 \$70,000

BUDGETING PROCESS

- Enrollment projections submitted in December of the previous year
- Teacher allocations made in February
- Funding allocations from the province received late March
- High needs assistant allocations
- Decentralized budget allocations

TRANSPORTATION

- Transportation funding limit used to be 2.4 km
- Limit changed to 1.0 km ECS Grade 6, 2.0 km Grade 7 12
 - Dramatic increase in funding
 - Targeted
 - Problems: Availability of drivers, busses, parking, families with children in each tier
- Limit changed to 1.6 km ECS Grade 6, 2.0 km Grade 7 12
 - One year of bridge funding for boards that adopted the new limits
- Transportation limit in BC: 4 km ECS Grade 3, 4.8 km Grade 4 12
- Concern over future transportation contract

 - Eliminated funding based on codes
